Screening for Learning Differences

All trainees who started ST1 in August 2020 were encouraged to undertake the screening tool for dyslexia, but trainees at any stage of training can be screened for dyslexia – further information on the HEW website https://wessex.hee.nhs.uk/wellbeing-and-support/psw/educator-info/make-a-referral/

We encourage all of our trainees to undertake screening for dyslexia as it is well recognised that trainees who have dyslexia may struggle in the MRCGP examinations due to the volume of text and data that is presented. If a diagnosis of dyslexia is made, then support and coaching can be arranged, in addition to the college allowing extra time to complete the AKT examination. If you have any concerns about dyslexia or would like to discuss the screening process in more detail then please do get in contact with your training programme director.

FourteenFish

Trainees who joined the GP Training Programme in August 2019 or before this date, have been given access to Wessex AKT & CSA Mid-Wessex community which was funded by HEE Wessex due to Covid-19. To access the resources simply log into your account and click the "Education" tab at the top of the dashboard. You can then click into the AKT and CSA packages via their individual icons.

ST1s or ST2s who don't have access already, can pay for access to both of these resources via FourteenFish and claim it back from their study budget during their hospital posts. Access is then available until the end of your training. The RCGP also provide free access to GP Self-test via the RCGP website for MRCGP preparation.

AKT Support

Mid-Wessex Programme Directors will be in touch with any Mid-Wessex trainees who have failed AKT in order to provide additional support.

Mandatory Training

All Mid Wessex GP Trainees are employees of either HHFT or SDH Trusts for the entirety of their GP training. Both trusts have mandatory staff training modules (which they will tell you about at induction) which it is your responsibility, and a requirement of your employment, to keep up to date with. Some of these modules, which are all accessed via your Hospital Trust, are also GP training requirements. You do not need to duplicate the training, but once completed for the trust please can you upload your certificates to your ePortfolio. Specifically, these are Child and Adult Safeguarding (which must be completed at the start of your first post and renewed annually) and Basic Life Support.
